

## LEGAL NOTICE

PLEASE TAKE NOTICE that the New York State Urban Development Corporation, doing business as the Empire State Development Corporation (“ESD” or the “Corporation”), pursuant to Section 16(2) of the New York State Urban Development Corporation Act (Chapter 174, Section 1, Laws of 1968, as amended) (the “Act”), has adopted General Project Plans (the “Plans”) with respect to the following projects:

City of Yonkers & Town of Chester (Westchester and Orange Counties) – Belmay MAP Capital – Empire State Economic Development Fund – General Development Financing (Capital Grant), at its meeting on January 20, 2012.

Town of Chester (Orange County) – C&S Wholesale Grocers Capital – JOBS NOW Program (Capital Grant), at its meeting on January 20, 2012.

Copies of the Plans are available without charge to any person who shall make a request for the same at the office of the Corporation. The Corporation will file such Plans in the office of the Westchester County Clerk’s Office, 110 Dr. Martin Luther King, Jr. Boulevard, White Plains, NY 10607, the Yonkers City Clerk’s Office, City Hall Room 107, 40 South Broadway, Yonkers, NY 10701, the Orange County Clerk’s Office, Orange County Government Center, 255 Main Street, Goshen, NY 10924 and the Town of Chester Clerk’s Office, 1786 Kings Highway, Chester, NY 10918.

A copy of each Plan is also on file at the principal office of the Corporation, 633 Third Avenue, New York, New York 10017, and is available for inspection by the general public Monday through Friday, between the hours of 9:00 a.m. and 5:30 p.m.

For Belmay MAP Capital: The Project includes the purchase, lease and installation of machinery and equipment to automate the company’s manufacturing operation at 200 Corporate Boulevard South, Yonkers and 45 Leone Lane, Chester by Belmay, Inc. Total Project costs are expected to be approximately \$2,003,634. ESD proposes to make a \$190,000 grant to Belmay, Inc. to assist in the financing of the Project. The Project is expected to retain 121 jobs within years after disbursement of the ESD funds.

For C&S Wholesale Grocers Capital: The Project includes the purchase an existing facility, construction of a refrigerated addition, and acquisition and installation of machinery and equipment at 1 Elizabeth Drive, Chester by C&S Wholesale Grocers. Total Project costs are expected to be approximately \$66,595,614. ESD proposes to make a \$1,353,000 grant to C&S Wholesale Grocers to assist in the financing of the Project. The Project is expected to retain 285 jobs and create 445 jobs.

PLEASE TAKE FURTHER NOTICE, that, in accordance with Section 16(2) of the Act, a public hearing, open to all persons, will be held by the Corporation at the Town of Chester Town Hall – Meeting Room, 1786 Kings Highway, Chester NY 10918 on Monday, February 13, 2012 from 11:00 am to 1:00 pm, to consider the Plan.
