Total Project costs are expected to be approximately \$2,825,000. ESD proposes to make a \$100,000 grant to Water Lilies Food, Inc. to assist in the financing of the Project. The Project is expected to retain 70 jobs/create 12 jobs within 4 years after disbursement of the ESD funds.
