

## LEGAL NOTICE

PLEASE TAKE NOTICE that the New York State Urban Development Corporation, doing business as Empire State Development (“ESD” or the “Corporation”), pursuant to Section 16(2) of the New York State Urban Development Corporation Act (Chapter 174, Section 1, Laws of 1968, as amended) (the “Act”), has adopted a General Project Plan (the “Plan”) with respect to the Greene County - Hurricane Irene-Tropical Storm Lee Flood Mitigation Capital Project (the “Project”), at the Directors' meeting on August 22, 2013. Copies of the Plan are available without charge to any person who shall make a request for the same at the office of the Corporation. The Corporation will file such Plan in the offices of the Greene County Clerk, County Office Building, 411 Main Street, Catskill, NY 12414; Lexington Town Clerk, PO Box 30, Lexington, NY 12452; Ashland Town Clerk, 12094 NYS Route 23, Ashland, NY 12407; Jewett Town Clerk, Jewett Municipal Building, 3547 County Route 23C, PO Box 132, Jewett, NY 12444; Halcott Town Clerk, 264 Route 3, Halcott Center, NY 12430; Hunter Town Clerk, PO Box 70, 5748 Route 23A, Tannersville, NY 12485; Catskill Town Clerk, 439 Main Street, 1st Floor, Catskill, NY 12414; Windham Town Clerk, 371 Route 296, Hensonville, NY 12439.

A copy of the Plan is also on file at the principal office of the Corporation, 633 Third Avenue, New York, New York 10017, and is available for inspection by the general public Monday through Friday, between the hours of 9:00 a.m. and 5:30 p.m.

The Project includes flood mitigation projects in the Town of Catskill, Town of Lexington, Town of Ashland, Town of Jewett, Town of Halcott and Village of Hunter by Greene County. Total Project costs are expected to be approximately \$3,068,116 and ESD proposes to make an \$878,222 grant to Greene County to assist in the financing of the Project. The Project is expected to reduce future flooding in areas affected by Hurricane Irene and Tropical Storm Lee.

PLEASE TAKE FURTHER NOTICE, that, in accordance with Section 16(2) of the Act, a public hearing, open to all persons, will be held by the Corporation at the Greene County Office Building, Suite 419, 411 Main Street, Catskill, NY 12414 on Wednesday, September 11, 2013 from 1:00 PM to 2:00 PM, to consider the Plan.
