

LEGAL NOTICE

PLEASE TAKE NOTICE that the New York State Urban Development Corporation, doing business as Empire State Development (“ESD” or the “Corporation”), pursuant to Section 16(2) of the New York State Urban Development Corporation Act (Chapter 174, Section 1, Laws of 1968, as amended) (the “Act”), has adopted a General Project Plan (the “Plan”) with respect to the Hurricane Irene – Tropical Storm Lee Business Flood Recovery Grant Program Project (the “Project”) pursuant to the Directors' meeting on January 20, 2012. Copies of the Plan are available without charge to any person who shall make a request for the same at the office of the Corporation. The Corporation will file such Plan in the offices of the Office of the Rockland County Clerk, Rockland County Courthouse, 1 South Main Street, Suite 100, New City, NY 10956; Putnam County Clerk’s Office, Putnam County Office Building, 40 Gleneida Avenue, Rm 100, Carmel, NY 10512; Westchester County Clerk’s Office, 110 Dr. Martin Luther King Jr. Boulevard, White Plains, NY 10607; Ulster County Clerk’s Office, Ulster County Office Building, 244 Fairs Street, Kingston, NY 12401; Sullivan County Clerk’s Office, Sullivan County Government Center, 100 North Street, PO Box 5012, Monticello, NY 12701; Orange County Clerk’s Office, Orange County Government Center, 255 Main Street, Goshen, NY 10924; Dutchess County Clerk’s Office, 22 Market Street, Poughkeepsie, NY 12601.

A copy of the Plan is also on file at the principal office of the Corporation, 633 Third Avenue, New York, New York 10017, and is available for inspection by the general public Monday through Friday, between the hours of 9:00 a.m. and 5:30 p.m. In addition, a copy of the Plan is posted at www.esd.ny.gov/PublicMeetings_Notices.html.

The Project includes up to \$21 million of a \$50 million Hurricane Irene – Tropical Storm Lee Flood Recovery Grant appropriation to be used to provide local assistance grants to be used for storm-related repairs and restoration of structures, and for other storm related costs, with individual grants not to exceed 50% of storm-related damages, up to a maximum of \$20,000. Individual applicants located in the Mid-Hudson region who are eligible for assistance are listed in the Plan.

PLEASE TAKE FURTHER NOTICE, that, in accordance with Section 16(2) of the Act, a public hearing, open to all persons, will be held by the Corporation at the Larkin Conference Room at 33 Airport Center Drive, New Windsor, NY 12553, on Friday, July 27, 2012 from 10:00 am to 11:00 am, to consider the Plan. In addition, ESD will accept written statements and comments about the Project submitted by 11:00 am, July 27, 2012, sent to Floodrecovery@esd.ny.gov.
