

General Business Financing includes programs that offer fixed asset and working capital financing for a wide variety of businesses. Listings for specialized financing includes employer incentives, programs for environmental improvements and green product development/manufacturing, and programs for minority, women, and disadvantaged businesses.

## GENERAL BUSINESS FINANCING

**Appalachian Regional Commission (ARC):** Assistance for economic development projects in fourteen counties in NY's Southern Tier (Allegany, Broome, Cattaraugus, Chautauqua, Chemung, Chenango, Cortland, Delaware, Otsego, Schoharie, Schuyler, Steuben, Tioga, and Tompkins counties). **Capital Access Program (CAP):** A newly expanded program that will provide \$18.4 million in matching funds to loan loss reserve pools at financial institutions, as an incentive to increase small business lending. **Commercial District Revolving Loan Trust Fund:** Loans to small retail and commercial business for working capital up to \$15,000, not to exceed 5 years. In addition, fixed asset loans of up to \$20,000, not to exceed 7 years are also qualified. This program is administered through 6 local development corporations around the state that serve a geographically defined target area. Call 212/803-3664.

**Community Development Financial Institutions (CDFI) and Other Alternative Lenders:** Loans and TA to small and minority and women businesses. **Job Development Authority (JDA) Direct Loan Program:** provides Direct Loans for the growth of manufacturing and other eligible businesses within New York State by assisting in financing a portion of the cost of acquiring and renovating existing buildings or constructing new buildings ("Real Estate" projects) or for purchasing machinery and equipment ("M&E" projects). Funds to make Loans are derived from the sale of State-guaranteed bonds.
